Don't forget that if you are due to renew your certification, you should start out at least 90 before your certification runs out. Get the BCII (fingerprint check) done and make sure it is sent to DODD not to you! The address to send it to is:

For the BCI Criminal Records check, indicate the reason for the fingerprinting as **5123.169 applicant for supported living certification**. For FBI criminal records check, indicate the reason for the fingerprinting as **5123.28 Employment with DODD**.

If you have not lived in the state of Ohio for the last 5 years then you will need a FBI check done. All applicants are to use "WebCheck" (Ohio's electronic fingerprint system) to submit their fingerprints to BCI and FBI. A list of all vendors, searchable by county, is available online at:
