### **DODD Waiver Information**

### **DID YOU KNOW?**

**Did you know that DODD has three different kinds of waivers that can pay for services for people who need them?**

---

#### **Level One Waiver - L1**

The L1 waiver is a good fit for people who do not need many paid support staff to provide services.

The Level One Waiver relies heavily on natural supports. Natural supports are services people provide without being paid for it.

Natural supports could be things like: support from a family member who helps you get dressed and ready for work every morning, a ride to work from a coworker, or a family member who provides a break or respite for caregivers.

#### Billing Codes for Level One Waiver

HPC Hours = FPC

Mileage - Non-Modified Vehicle = FTN

Mileage - Modified Vehicle = FTO

## Individual Options Waiver - IO

The IO waiver is a more comprehensive waiver. It can be a good fit for people who may need a lot of help in their home, or for people who need many different services.

### Billing Codes for Individual Options Waiver

HPC Hours = APC

Mileage - Non-Modified Vehicle = ATN

Mileage - Modified Vehicle = FTN

## Self - Empowered Life Funding Waiver - SELF

The SELF Waiver is a good fit for people who want to manage some of their services.

If someone has has a SELF Waiver, they can be in charge of hiring and training the people who provide their services. They can manage their budget for the services they want.

As the provider you need to remember the following when serving someone on a SELF Waiver:

- You need to be certified in PD-HPC
- You will be an employee of the person you are supporting
- Wages are different than billing the waiver directly
- GT Independence will withhold taxes and send you a w-2
- You will work with the individual and GT Independence to complete time sheets

### Billing Codes

*GT Independence completes all billing based upon your time sheets.*
